For the Kids' Sake: A Parenting Seminar

By order of Snohomish County Superior Court Local Rule, seminar attendance is mandatory for all parents involved in divorce, paternity or custody proceedings filed after September 1, 1994.

For the Kids' Sake seminars are provided through a contract with Snohomish County Superior Court to satisfy this mandatory requirement. Seminars are scheduled four times each month at various Snohomish County locations.

The purpose of this seminar is to help parents understand how children are affected by separation and parental conflict. Seminar topics include:

- How to protect my child from parental conflict
- How to recognize when divorce and separation is affecting my child
- How to communicate better with the other parent
- How to get further help if I or my child needs it

The Facilitators are masters level therapists and have extensive experience helping children and families with difficulties related to separation and divorce.

At the end of the seminar, you will receive a certificate which is to be given to your attorney for filing with the court (or if acting pro se, you must file it yourself). There is no fee to file a certificate.

Please read the directions below completely and carefully.

You Must Pre-Register by Mail

Seminars are filled on a first-come basis, so early registration is encouraged. *You will receive an emailed confirmation with the seminar location, date and time once your registration is received.*

To Register:

1. **Complete the registration form.**
Each parent/party must complete a registration form. The name of the other parent/party is required. You will be scheduled to attend a seminar separate from the other party, unless both parties submit a written statement requesting joint attendance.
2. **Obtain a money order or cashier's check,** payable to *For the Kids' Sake*.
The fee for the class is on a sliding scale based on net monthly income. Net income is determined by deducting taxes and social security from your gross income. Do NOT subtract any other deductions or payments to determine your income. **(See Fee Schedule Chart ↗)**
3. **Provide proof of income, if needed.**
If you pay less than the full \$125 fee, you must send in verification that you fall within the income bracket used. Verification of one month's income is sufficient. It can include pay stubs, child support checks, welfare or DSHS paperwork, unemployment or disability paperwork, or a signed, hand-written financial declaration if you have no income.

4. **Mail your items** (registration form, money order & proof of income, if needed). *Registration closes 72 hours prior to seminar, so please mail your registration as soon as possible.*

Seminar Fee Schedule:

NET MONTHLY INCOME OF PARENT FROM ALL SOURCES*	FEE
\$3,501 and above	\$125
\$2,501 to \$3,500	\$100
\$2,001 to \$2,500	\$70
\$1,501 to \$2,000	\$40
\$0 to \$1,500	\$10

*Income sources include: wages, child support, DSHS and/or any government income

Refund Policy: If you cancel at least 72 hours in advance, we will refund your fee minus a \$10 processing fee. If less than 72 hours notice is given, one-half of the fee will be refunded. No refund will be given if you do not notify us before the class or if you do not show up.

Reschedule Policy: We will reschedule your seminar one time for free if you call at least 72 hours in advance. There is a \$10 fee each time you reschedule after the first time, or if you give us less than 72 hours notice.

No Refunds or Reschedules are processed after four months from initial receipt of fee.

Children are not allowed, so please make any necessary childcare arrangements.

A Security Officer is on site at each seminar to assure the safety of all participants and appropriate participation.
